

RIDE ON MOTORCYCLES

MOTORCYCLE TRAINING

TERMS AND CONDITIONS

CBT

1. A CBT ENTITLES THE TRAINEE TO A TOTAL OF 8 HOURS TRAINING.
2. TO CANCEL A CBT WE REQUIRE 48 HOURS NOTICE, OTHERWISE THE PAYMENT WILL BE FORFEITTED.
3. CBT INCLUDES ACCIDENTAL DAMAGE COVER.
4. ANY MEDICAL CONDITIONS MUST BE MADE KNOWN TO THE INSTRUCTOR BEFORE COMMENCEMENT OF THE COURSE
5. I UNDERSTAND THAT A CBT CERTIFICATE WILL NOT BE ISSUED TO ME UNTIL I MEET THE REQUIRED STANDARDS AS STIPULATED BY THE DRIVING AND VEHICLE STANDARDS.
6. I UNDERSTAND THAT ALTHOUGH IT IS POSSIBLE TO COMPLETE A CBT TO THE REQUIRED STANDARDS WITHIN A DAY (8 HOURS) IT IS SOMETIMES THE CASE THAT IT MAY TAKE MORE TIME TO MEET THE REQUIRED STANDARDS. I UNDERSTAND THAT THE CBT IS A SAFETY COURSE.
7. I UNDERSTAND THAT I WILL BE REQUIRED TO READ A NUMBER PLATE AT A DISTANCE OF 20.5 METRES.

GENERAL

8. RIDE ON MOTORCYCLES RESERVES THE RIGHT TO REFUSE ANY TRAINEE WHO WE MAY CONSIDER TO BE A DANGER TO THEMSELVES OR OTHERS.
9. I UNDERSTAND THAT I AM RIDING THE TRAINING BIKES AT MY OWN RISK AND THAT RIDE ON MOTORCYCLES LIMITED ARE NOT LIABLE IN ANYWAY FOR SUBSEQUENT PERSONAL INJURY OR DAMAGE TO CLOTHING AND PERSONAL BELONGINGS.
10. TRAINEES ARE RESPONSIBLE FOR THE CARE OF THE MOTORCYCLE UNTIL THE KEYS ARE RETURNED TO THE INSTRUCTOR.
11. 48 HOURS NOTICE IS REQUIRED TO CANCEL A LESSON OTHERWISE THE LESSON WILL BE CHARGED AT THE HOURLY RATE.
12. THE DVSA REQUIRE 10 WORKING DAYS NOTICE TO CANCEL A TEST. A DOCTORS SICK NOTE IS REQUIRED TO AVOID RE TEST FEE.
13. TESTS AND RE-TESTS WILL ONLY BE CONFIRMED ONCE THE FEE IS PAID.
14. I UNDERSTAND THAT, IF USING MY OWN BIKE FOR THE PURPOSE OF MY TRAINING, IT IS MY RESPONSIBILITY TO ENSURE THAT MY BIKE IS APPROPRIATELY INSURED, TAXED AND MOT'D AND MEETS ALL LEGAL REQUIREMENTS FOR A LEARNER MACHINE.
